PROCEDURE FOR ASSESSMENT OF STUDENTS

Students will be assessed out of maximum 100 marks for each subject

Internal Assessment 20 Marks

Existing policy laid out in circular number Acad-11/2019 dated March 6, 2019

All schools should upload the marks of Internal Assessment latest by 11th June 2021



Policy For Year-end Assessment of 80 Marks

- Based on the marks scored in the different tests/exams conducted by the school during the year
- Marks should be in consonance with the past performance of the school in Class X Board examinations.



RULES FOR THE FORMATION OF RESULT COMMITTEE (1/2)

- While co-opting teachers, the following should be strictly ensured for the fairness of the result:
 - Teachers should be teaching class X in the neighboring school affiliated to CBSE
 - No interchange of teachers as committee members between two schools
 - Teachers should not be from the same management schools
 - Teachers should not be from the school where the Principal is the Co-opted member in the Management/ School Committee.
 - Any other relationship which may influence the result of the school/student
- Ward(s) of the committee members should not be appearing from the same school.
- CBSE may also appoint two external members in the Committee.

RULES FOR THE FORMATION OF RESULT COMMITTEE (2/2)

- To deliver fair and unbiased results.
- · Committee should be well adquainted with the Policy.
- Discussions among themselves to arrive at a common understanding.
- One Committee may discuss with another Committee
- Make themselves aware about the ground realities in the school and frame the rationale for assessment.
- Committee can make its own schedule based on the schedule provided by CBSE.
- Opinion of other subject teachers may also be obtained by the Committee.
- Everyday proceedings should be recorded in Rationale document by the committee.
- Committee will keep all the proceedings confidential.
- Infrastructure by Chairperson of the committee
- External committee members -Public Representatives to ensure fairness & equally responsible
- In nutshell, it is the sole responsibility of the committee to prepare fair and unbiased results of the students.
 Therefore, Committee is fully competent to take any justified decision in writing looking into the ground realities

Range of Marks

PROCEDURE FOR ASSESSMENT OF STUDENTS

Internal moderation of marks (Illustrative example)



- The Board will provide the broad distribution of marks across students for a particular subject, for the school
- The distribution of marks is based on the performance of the school in the subject in Class X Board Exams in specific reference year.
 Say you selected 2019-2020. BOARD WILL MAKE THIS AVAILABLE

Marks Range	<26	≥26 to 40	>40 to 50	>50 to 60	>60 to 71	>70 to 80
Percentage of total students having marks in the particular range.	1%	14%	25%	10%	20%	30%

 In case the school gets the above distribution and for 2021 exams 200 students have to be assessed then the school assessed grades of the students should broadly be distributed across range of marks as per the following table

- The school has enough flexibility for assessing individual students.
- However, overall distribution of marks should fall in the defined ranges.

(1/3)



Verification of data

- Verification by sending teams
- A check on the uploaded data
- Schools would be asked to submit their record to the Regional Office concerned and these documents will be verified by a team of experts deputed by CBSE.

Non compliance

- In cases where the school deliberately indulges in practices that are not fair, unbiased and objective CBSE reserves the right to:
- start dis-affiliating proceedings and/or
- impose financial penalty against the school or
- decide not to declare the result of Class X for the school till the time it is not in conformity with the Board's Policy.

Uploaded data is final

- Data of both internal and external assessment once filled by the school shall be considered final.
- No request for correction of marks because of wrong entry or mistake of any sort will be allowed.
- Hence, due care should be taken while uploading all marks on part of the school.

Candidate not assessed

- If any candidate has not appeared in any of the assessments conducted by the school, the school may conduct
- an offline/online or a telephonic one to one assessment and
- record documentary evidences to certify the recommendations.
- The student may be assessed objectively on that basis by the school out of maximum marks of each subject.

Candidates with Disabilities

- If any student with benchmark disability has not appeared in any of the assessments conducted by the school,
- the school may consider other activities such as Portfolio, Presentations, Project, Quiz, Oral Test, etc. done by such candidates during the session for assessment in place of offline/online assessment and
- record documentary evidence in such cases.

After Result Declaration

- · As assessment has been done by the schools and
- · the answer books have shown/handed been over to the students by the school,
- · process of verification of marks, providing and photocopy reevaluation scheme will not be applicable for Session 2020-2021.

Mathematics Class X Vs XI

- · In continuation to the Circular No.Coord/Printing/2020 dated 06.08.2020
- exemption has again extended been to permit Mathematics (01) in Class XI, if a has offered student Mathematics Basic (241) in Class X.
- All other conditions as stipulated in above said circular will remain same.

Stream in Class-XI

- · As per the scheme of studies of the Board, students are allowed to offer any combination of subjects without any streaming,

METHODOLOGIES TO ADDRESS SKEWNESS OF RESULT

- the Result Committee may decide to give weightage to the students' performance in Class IX
- b) and/or other periodic evaluations including project based assessments which are an objective measure of the academic performance of the students.
- c) Overall average marks in the subject for the school in the Board Examinations of the specific reference year. The overall average marks assessed for each subject by the school should not exceed the average marks obtained in the subject by the school in the Board Exams of the specific reference year.


CHECKS AVAILABLE IN THE ONLINE SYSTEM

- a) Once the uploaded school based assessment marks are consistent with the Board's policy, the school will be able to finalise the marks on the Board's portal.
- b) In case marks are not consistent with the Boards policy, schools will not be able to upload marks on the Boards portal.


